This is an official demand for investigation and public hearing into the actions of the the Mayor and City Administrator under the City Ordinance 1.27 Ethics. There have been actions committed by the Mayor and City Administrator which are punishable by City of Delta Junction Ordinance and possibly Alaska Criminal Codes. There have been many ethical violations by above mentioned parties which go against City of Delta Junction Ordinance and have broken the trust relationship between all parties listed and the Community. This has also been a bad reflection upon the City Council for their failure to correct. The acts which have broken City of Delta Junction Ordinance are as follows:

- 1. The Mayor and City Administrator did in fact enter into an illegal contract for services over \$25,000 by engaging and agreeing to services with a company FW Scott Enterprises in the amount of \$40,000 without following Ordinance or alerting the City Council. This goes against procurement City Ordinance 1.41.027
- 2. The Mayor and City Administrator did in fact issue a check for \$40,000 to FW Scott Enterprises without knowledge nor consent of the council. This goes against City Ordinance 1.35.060 Checks over \$1000.
- 3. The Mayor and City Administrator kept this Transaction hidden for a period of 2 meetings after services were obtained and check for \$40,000 was issued to FW Scott Enterprises.
- 4. The Mayor deliberately made statements and lied to mislead the council about this transaction by stating in The November 7. 2023 meeting that, "That normally this check did not need to be reported to the council" when in fact in did under City Ordinance 1.35.060
- 5. The Mayor himself has admitted during the course of the landfill construction that he had broken MORE procurement City Ordinances because as he has stated multiple times, "The City Council gave me \$450,000 to spend on the landfill therefor I did not have to follow any Ordinances to spend that money". This statement made by the Mayor was INCORRECT and if the council did indeed believe that they had given the mayor this power this within itself was an illegal act. When the mayor decided to micro manage and compartmentalize the landfill project ALL City Ordinances needed to be adhered to for ALL PROCUREMENT during this project. The council needs to investigate the actions of the Mayor and City Administrator further.
